REQUIREMENTS TO THE MATERIALS:

1. Thesis requirements:

- thesis should be sent in the editor MS Word .docx;
- volume – **up to 3 A4 pages**;
- **fields:** top – 2 cm, bottom – 2 cm, left – 2 cm, right – 2 cm;
- font – **Times New Roman**, size – **14**; spacing – **1,15**;
- **the name of thesis** is in bold, capital letters, the following line specifies **the name and initials of the author (s)**, below – **the name and initials of the scientific supervisor** (with academic status); on the next line – **the full name of institution, city, country**, below – **e-mail of the author** with whom to correspond to;
- authors' academic titles and scientific degrees should not be mentioned;
- **the mandatory structure of thesis:** introduction, purpose of the study, materials and methods, results and conclusions. Abbreviations and terms are not permitted in the title of the thesis. Literature references are not specified. The system of units SI must be used. Abbreviation stands after the first mention in the text and does not change throughout the work;
- in decimal point should be used (eg, 0.1 or 0.358). Symbols «<», «>», «%», «±» are written without separation from previous characters, for example, p <0.95, t> 37 °C, 16%, 0.23±0.01. In the text of the thesis bold, italics, and other decorating techniques are not used;
- usage of tables, graphs, diagrams and illustrations are allowed.
- **file name:** number of the session_ full name (eg, 1_Ivaschenko A.G.).

2. Requirements for poster presentation:

- The title of the work are indicated at the top of the poster (capital letters, bold type, no more than three lines), on the next line - surname and initials (without selection, degrees are not specified); below - full name of institution, city, country; on the next line - e-mail of the author
- in the upper right corner (above the title) specify the name of the key area (without selection);
- poster presentation should contain the material of scientific research: purpose of research, materials and methods, results in the form of graphics, tables, diagrams, illustrations, charts, drawings (the size of which does not exceed the size of A4 paper) and conclusions;
- poster size: A1 (594 x 841);
- the size of the used font must provide reading at a distance of 100 cm.
