conference:***

3. Safety of pharmacotherapy and pharmacovigilance system.
4. Age, gender, chronopharmacological and pharmacogenetic factors of rational use of medicines.

6. Information technology in clinical pharmacology and clinical pharmacy.
7. Organizational and managerial approaches to ensuring the rational use of medicines.
8. Evaluation of health care technologies, pharmacoeconomic research and formulary system as components of rational pharmacotherapy.
9. Technological (nanotechnological) aspects of the development, implementation and use of medicines.
10. Preclinical and clinical trials of medicines.
11. Methodological aspects of teaching pharmacology, clinical pharmacology and clinical pharmacy in Ukraine and the world.

**PUBLISHING MATERIALS
WITHOUT PAYMENT**

Materials of the conference will be published in the collection of articles and abstracts. The author is responsible for the content of the materials. Materials are not peer-reviewed, documents executed in violation of the requirements are not accepted.

Deadline for submission of materials – October 15, 2023.

Requirements for publications:

The volume of articles is up to 5-10 pages, abstracts 1-2 pages (FULL PAGES),

line spacing - 1, A4 sheet, font - Times New Roman, size - 14 pt. The indent is 1.25. Microsoft Word text editor.

Margins: 2.5 cm on each side, no pagination.

Article structure

UDK (upper left bold), title of the article (capital letters, bold), initials and surnames of all authors (bold italics), name of the organization in which the work was done (italic), city, country, e-mail.

The article is accompanied by abstracts in Ukrainian and English, 2/3 pages of typewritten text with headings: purpose; materials and methods; results; conclusions. Abstracts must contain the UDK index, the title of the article, the initials and surnames of the authors.

Further from the paragraph (through an empty line) the text of the article. The text of the article must comply with the current requirements, and the authors must adhere to the general plan for the construction of the article and contain the following structural components: **introduction, materials and methods of research, results and discussion, conclusions, list of used sources of information.**

Tables, figures, charts and diagrams should be numbered headings. The width of the graphic material should be 5.5 cm, 11.5 cm or 17.4 cm.

Design of literature in accordance with DSTU 8302: 2015 or international standard APA.
