## **REQUIREMENTS FOR ABSTRACTS**

Thesis volume - 1-3 full pages (MS Office Word 2003: A4 page format with margins of 2 cm; font - Times New Roman, 14 point, 1.0 space); without pictures, graphs and a list of sources.

**Abstracts:** title in **CAPITAL LETTERS** in the center of the sheet, from the new line - **surname, initials of the authors** (bold, in the center), the next line - the full name of the institution, city, country, e-mail (center), through the line from the paragraph - main text.

The structure of the main sections of theses: introduction, purpose, materials and methods, results and their discussion, conclusions. The introduction also reflects the relevance of the study.

All abbreviations (except units) can be used only after mentioning the full term. No reductions are allowed in the goal and conclusions!

Abstracts should contain the results of their own research. The author is fully responsible for the content of the materials provided, the accuracy of the results and compliance with intellectual property rights. The Organizing Committee reserves the right to refuse publication if the submitted work does not meet the requirements.

**The application of the participant** is made out on the author of theses (**on Google forms**) who is the first, and also on the speaker in one file. In the case of an oral report, the full names of the author's team must be indicated. The name of the file with the registration card after the name of the first author (for example, "Ivanov\_RK", in Cyrillic).

The presentation is made in the Microsoft PowerPoint editor (file name after the first author) (for example, "Ivanov\_P", in Cyrillic).

## **REQUIREMENTS FOR ORAL REPORT**

- regulations - 10-15 minutes;
- Be sure to multimedia support the report.
